

Abstract: In this presentation we discuss the non-Gaussian alternatives to model financial volatility. The comparison has been made between two special cases of the GH distributions. We derive the stationarity conditions, moments, dependence structure to account for heavy tails and leverage in the data and discuss several estimation strategies to the proposed non-Gaussian model. Finally through some empirical investigation the model efficiency has been evaluated using real data.
